3. If the above appointment is terminated before construction of the works has been completed, I undertake to notify the *Local Authority immediately of this in terms of Regulation A19(2).

4. I undertake to submit a certificate to the *Local Authority in terms of section 14(2A) of the National Building Regulations and Building Standards Act, 1977 (Act 103 van 1977) on completion of the above-mentioned proposed works, in which it must be indicated that the structural strength is in accordance with the application in respect of which approval was granted under section 7 of the Act and certify compliance with the SABS 0400 specifications and regulations.
