2. OFFICE OF THE SPEAKER

PETITION FROM RESIDENTS REQUESTING PERMANENT CLOSURE OF ALL DANGEROUS ALLEY WAYS IN DANVILLE AND ITS EXTENSIONS DUE TO HIGH RISK OF CRIME, DRUG ABUSE AND HEALTH RISKS, WARD 60, REGION 3, UNDER CLLR M RAMPHILE

Before commencement of the discussion of this matter, at the Section 79 Standing: Petitions meeting of 23 November 2023, the Ward Cllr, Cllr M Ramphile was present and was given an opportunity to address the committee.

After hearing the above deliberations by Cllr Ramphile, representative from the TMPD: Region 3, Sector 1 alluded that regular patrols are done even though refuse is always piling up due to the strike of employees, however the Department of Waste Management will be roped in for them to always clear the allies for the sake of health and safety reasons in the area.

In view thereof, the Section 79 Standing Committee: Petitions resolved as set out below.

RESOLVED:

- 1. That the Group Head: Roads and Transport should close off all alleyways in Danville to safeguard residents.
- 2. That the Group Head: Waste Management clean up all alleyways in Danville.
- 3. That the Chief of Police should continue to monitor and patrol the area for any illegal activity on regular basis.

3. OFFICE OF THE SPEAKER PETITION FROM RESIDENTS REGARDING DEVELOPMENT THAT IS AFFECTING PROPERTIES AND QUALITY OF LIFE IN WARD 101, REGION 6, UNDER CLLR M DE KLERK

Before commencement of the discussion of this matter, at the Section 79 Standing: Petitions meeting of 23 November 2023, the petitioners were present and were given an opportunity to address the committee.

After hearing the above deliberations by the petitioners, the following Cllrs took part in a lengthy debate:

Cllr LKP Moloto Cllr T Vilakazi Cllr E Sparg Cllr BW Lawrence Cllr TJ Shume Cllr P Ramjee

It was at that point where CIIr Vilakazi proposed and seconded by CIIr E Sparg amendments to recommendations 1 and 3 to read as follows, which the proposal was accede to by the Committee:

- "1. That the Chief of Police continue to conduct regular law and by law enforcement and deployments not only during peak hours, but also late hours at night."
- 3. The Group Head Municipal Health to conduct inspection on noise pollution without informing Pick and Pay (TAE Tennant) and that the Regional Head report back to the Section 79 Standing Committee: Petitions by 15 February 2024."

Hereafter a representative from the TMPD, assured the committee that noise levels measurements will be done and that a feedback report will be given at the next sitting of the Section 79 Standing Committee: Petitions.

In view thereof, the Section 79 Standing Committee: Petitions resolved as set out below.

RESOLVED:

- 1. That the Chief of Police continue to conduct regular law and by law enforcement and deployments not only during peak hours, but also late hours at night.
- 2. That the Group Head: Spatial Planning and Economic Development should conduct an inspection on building compliance.
- 3. The Group Head Municipal Health to conduct inspection on noise pollution without informing Pick and Pay (TAE Tennant) and that the Regional Head report back to the Section 79 Standing Committee: Petitions by 15 February 2024.

4. OFFICE OF THE SPEAKER PETITION FROM RESIDENTS REQUESTING ELECTRICITY, STORMWATER STREET LIGHTS, POTHOLES AND WATER CRISIS, WARD 17, REGION 6, UNDER CLLR S LELAKA

Before commencement of the discussion of this matter, at the Section 79 Standing: Petitions meeting of 23 November 2023, the petitioners as well as the Ward Cllr, Cllr S Lelaka were present and were given an opportunity to address the committee.

After hearing the above lengthy deliberations by the petitioners, Acting Director: Energy and Electricity, alluded that the Department of Human Settlements, should intervene and demarcate the area, and that illegal occupation of residents under the reservoir is the major problem.

Further, he indicated that for streetlights, there was no budget set aside for the maintenance due to the City being under financial constraints.

In view thereof, the Section 79 Standing Committee: Petitions resolved as set out below.

RESOLVED:

- 1. That the Group Head: Roads and Transport to include the budget for resurfacing of roads in the area in the 2023/2024 financial year.
- 2. It be noted from GH: water and sanitation department comments that City of Tshwane started with the application to receive an eviction order to remove all illegal occupants. Removal of illegal connections will be carried out once the illegal occupants are evicted from the reservoir sites. That the Regional Head give feedback in 15 February 2024 at the Section 79 Standing Committee: Petitions meeting.
- 3. That the Group Head: Energy and Electricity ensures that the power supply at the mentioned area is in accordance with the standards of the City.
