5. OFFICE OF THE SPEAKER
PETITION FROM RESIDENTS OF GARANKUWA ZONE 4 REGARDING SERVICE
DELIVERY, WARD 30, REGION 1, UNDER CLLR V PHALWANE
(From the Section 79 Standing Committee: Petitions: 17 November 2022)

During the meeting of the Section 79 standing Committee: Petitions of 22 February 2024, the petitioners were present and were given the opportunity to address the committee.

After hearing the above deliberations and concerns by the petitioners also residents, Divisional Head: Human Settlement Department: Ms Petal Thring, gave a thorough understanding and process on the matter the tittle deeds as follows:

- That the current court tittle deeds are part of the North West Housing Cooperation properties, that were sold by in 2002, when the City of Tshwane was established.
- The matter was reverted to the city.
- The National Department of Human Settlement provided funding to the Provincial Department of Human Settlement, to begin this process, which it did.
- The process was extremely slow due to the various complaints that were long lodged, therefore the Minister has taken over the project.
- A first team of conveyancers was appointed last year, and that contract came to an end late in the year and a new team of conveyancers was appointed by National Department of Human Settlement.
- There's only been two tittle deeds issuing event in the area since then and assurance was made that now with the new conveyancing team appointed, the process will be expedited.

Deputy Director: Human Settlement: Mr Franswa Swanepoel, brought to light to the committee that, in this matter most things are deal with by the province and that he is only responsible for the township establishment subdivisions, so it would be difficult to account on behalf of the province.

Here after, the Chairperson S Wilkinson, recommended that in this event, recommendation 2 of the recommendations of the report be removed until a proper progress report be handed to the committee which the proposal was acceded by the committee.

He further iterated that Director: Petitions and Memoranda: Russel Sambu, be responsible in coordinating (IGR) Inter Governmental Relations and the petitioners and the Ward Councillor should form part of the hearing / oversight to make sure that the matter is discussed in depth, because they have an intimate knowledge of the area and areas like that, as well as the consolidation of who has passion for these community development interventions.

In view of the above, the Section 79 Standing Committee: Petitions resolved as set out below.

- 1. That the Group Head: Human Settlements ensures that title deeds process is finalized and issued to the rightful owners.
- 2. That the Group Head: Human Settlements should investigate if the Houses were not built on wetlands and submit a report to the Petitions Committee by the June 2024.
